### VI. ADOPTION OF RESOLUTION FOR E-LEARNING PLAN

The Superintendent read the Resolution into the record.

**WHEREAS**, the Administration has presented an initial E-Learning Plan to the Board of Education of Ridgewood High School District 234, for its review and approval, a copy of which is hereby included, by reference; and,

WHEREAS, the District has published and otherwise given the Notice of Public Hearing regarding the proposed E-Learning Plan as required by the School Code; and,

**WHEREAS**, the District at its Regular Board Meeting of June 23, 2025, has conducted a Public Hearing regarding the initial E-Learning Plan; and,

WHEREAS, the Board of Education finds that said Plan, as proposed in its initial and final form, and as presented during the Public Hearing, meets the requirements of the School Code, including but not limited to the requirements of Section 10-20.56 (105 ILCS 5/10-20.56); and,

WHEREAS, the adoption of said Plan will permit the Administration to use said Plan, in its discretion, to permit student instruction to be received electronically while students are not physically present, in lieu of using the District's scheduled emergency days; and

**WHEREAS**, the Board finds that the adoption of said Plan is in the best interest of the District.

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of Ridgewood Community High School District 234 as follows:

**SECTION 1**: The E-Learning Plan, as presented during the Public Hearing and as presented to the Board, which Plan is included herein by reference, is hereby adopted.

**SECTION 2**: This Plan is adopted for a term of three years.

**SECTION 3**: The Superintendent or designee is authorized to make any necessary modifications to the Plan deemed necessary by the Regional Office of Education or the State Board of Education.

**SECTION 4**: The Superintendent or designee is hereby authorized and directed to take all actions and submit and execute all documents necessary to implement said Plan.

**SECTION 5**: This Plan shall meet the requirements as set forth by Section 10-20.56 of the Illinois School Code.

**SECTION 6**: This Resolution shall take effect immediately upon its passage.
