I hereby acknowledge and guarantee that in the event there is an investigation, hearing and or judicial ruling of any kind resulting in a determination that my student(s) is not a resident of District 234 at any time after the signing of this document I shall be personally liable for all expenses related to the determination of non-residency by District 234, including, but not limited to investigation expenses, attorney's fees, hearing fees, consulting fees, travel expenses and collection expenses in addition to the tuition charge as established by the *Illinois School Code*. I further acknowledge that any person who enrolls or attempts to enroll in the schools of a school district, on a tuition-free basis, a pupil known by that person to be a nonresident of the district, or any person who presents to any school district any false information regarding the residency of a pupil for the purpose of enabling that pupil to attend any school in the District without the payment of a nonresident tuition charge, shall be guilty of a Class C misdemeanor.
